COMMENT ON 7.D. on the Agenda of today's CCSD meeting, March 19, 2020

In view of the precarious nature of the District's financial health, I oppose the proposal that the District absorb the cost of the transfer of this meter. It isn't just a matter of "waiving" the fees....there is actual COST involved, estimated from \$2,500 upwards.

Just as the District has re-examined its former policies about not charging fees for the use of the Vets Hall and perhaps other publicly owned facilities, the District should pass along the full cost of meter transfers to the applicants.

Also, the staff report questions the ownership of the meter, and until that is fully resolved I suggest that this entire matter be shelved. To move forward with the transfer of a meter of unknown ownership may well expose the District to legal action.
