As the Board is aware, the State and County of San Luis Obispo have adopted a number of executive orders declaring a public health emergency and imposing restrictions on the general population to help control the spread of the COVID-19 virus. Adoption of Resolution number 2020-09 provides the General Manager with increased spending and other authority to allow for a more expeditious and effective response to various situations related to the COVID-19 pandemic as they occur. Additionally, the District may be eligible for cost recovery from the Federal and State governments on matters and acquisitions related to the COVID-19 pandemic.

#### **RESOLUTION 2020-09**

# DECLARATION OF EMERGENCY AND RESOLUTION OF THE CAMBRIA COMMUNITY SERVICES DISTRICT BOARD OF DIRECTORS TO TEMPORARILY AUTHORIZE INCREASED AUTHORITY OF THE GENERAL MANAGER

- WHEREAS, on March 4, 2020, the Governor of the State of California declared a State of Emergency to exist in California as a result of the threat of Novel Coronavirus 2019 ("COVID-19"); and
- **WHEREAS**, on March 12, 2020, the Governor issued Executive Order N-25-20 in further response to the spread of COVID-19, mandating compliance with orders of State and local public health officials as they pertain to measures to control the spread of COVID-19; and
- **WHEREAS**, on March 13, 2020, the San Luis Obispo County Health Officer declared a public health emergency and the County Emergency Services Director also proclaimed a local emergency due to the COVID-19 pandemic; and
- **WHEREAS**, on March 14, 2020, the San Luis Obispo County Public Health Department announced the first confirmed case of COVID-19 in San Luis Obispo County, and additional cases have since been confirmed; and
- **WHEREAS,** on March 19, 2020, the Governor of the State of California issued an Executive Order N-33- 20, ordering all individuals living in the State of California to stay at home or at their place of residence to preserve the public health and safety; and
- **WHEREAS**, the health, safety and welfare of the Cambria Community Services District ("District") residents, businesses and visitors, are of utmost importance to the Board of Directors ("Board"), and additional future measures may be needed to protect the community; and
- **WHEREAS**, preparing for, responding to, mitigating, and recovering from the spread of COVID-19 may require the District to divert resources from normal day-to-day operations and it may impose extraordinary requirements on and expenses to the District; and
- **WHEREAS**, the General Manager currently has spending authority up to \$25,000, without prior Board approval in addition to limited authority related to personnel matters; and
- **WHEREAS**, in the absence of Board action, strict compliance with certain District rules and ordinances could prevent, hinder, or delay appropriate actions to prevent and mitigate the effects of COVID-19; and
- WHEREAS, after consideration of all the facts reasonably available for review at the present time, the Board finds it in the best interest of the District to authorize the increase in General Manager spending authority to \$35,000, and up to \$50,000 upon authorization from the President of the Board, and approves all acts necessary and

appropriate to ensure the operation of the District, the safety of employees, and the safety of the public.

**NOW, THEREFORE, IT IS HEREBY RESOLVED** by the Board of Directors of the Cambria Community Services District, as follows:

- 1. The Board of Directors declares a State of Emergency to exist in the Cambria Community Services District as a result of the threat of Novel Coronavirus 2019.
- 2. The Board of Directors authorizes an increase in the General Manager's spending authority to \$35,000, and up to \$50,000 upon authorization from the President of the Board.
- 3. The General Manager may take all actions necessary, proper, and appropriate in his/her reasonable discretion to ensure the operation of the District, the safety of employees, and the safety of the public, including, but not limited to reasonable deviations from Board adopted Ordinances, Resolutions, Policies, Procedures, and Agreements.
- 4. The authority vested in the General Manager by this Resolution will terminate upon a declaration by the Governor that the State of Emergency has ended, the County Health Officer that the Public Health Emergency has ended, and the County Emergency Services Director that the Local Emergency has ended.
