## **Have Cambrians been conserving water?**



In 2013, not much.

In 2014-15, between one fourth and one half of water used in 2013!

From 2016 to now, not quite as much water conserving.

## **Residential** conservation varies from

- <u>nearly half</u> of 2013 usage conserved in 2015,
- to about one-fourth in 2020 during the stay-at-home regulation in the pandemic, and
- back up to 41% conserved in the first 6 months of 2022.

## **Commercial** accounts conserved


- about a fourth of 2013 usage,
- to about one-third in 2020 in the midst of the stay-at-home rule in the pandemic, and
- back down to less than one-fifth conserved in the first 6 months of 2022.

Look at the chart on the next page for year-by-year conservation comparison.

Before the drought emergency, 2013 usage provides a baseline of water use in Cambria. In the drought, what was <mark>conserved—not used</mark>—each year from 2014 to 2022 is shown here in percentages.

For example, In 2014 residents used 47.9% LESS water than they used in 2013; commercial accounts used 25.9% LESS.
