RECOMMENDATIONS:

It is recommended that the Board of Directors discuss and consider approving the attached Amendment to Agreement for Use of Well SR4 at Coast Union High School and Grant of Related Easements (the "Amendment") with Coast Unified School District ("CUSD").

FISCAL IMPACT:

The amendment carries an annual expense of \$36,000 over ten years, for a total of \$360,000. This reflects an approximately \$10,000 annual decrease from the payment from last year.

DISCUSSION:

The CUSD Board of Trustees held a special meeting on September 28, 2023, at which they approved the attached proposed Amendment. The annual cost of the proposed Amendment has been reduced by approximately \$10,000 and the Consumer Price Index increases have been eliminated.

Staff recommends the Board discuss and consider approval of the proposed Amendment.

AMENDMENT TO AGREEMENT FOR USE OF WELL SR4 AT COAST UNION HIGH SCHOOL AND GRANT OF RELATED EASEMENTS

This Amendment to Agreement for Use of Well SR4 at Coast Union High School and Related Easements ("Amendment") by and between the CAMBRIA COMMUNITY SERVICES DISTRICT ("CCSD") and COAST UNIFIED SCHOOL DISTRICT ("CUSD"), is made and entered into this 10th day of August, 2023.

WHEREAS, the parties entered into an Agreement for Use of Well SR4 at Coast Union High School and Related Easements dated September 27, 2012 (the "Agreement"). The parties twice modified to extend the termination date with the current termination date being September 30, 2023; and

WHEREAS, the parties desire to amend the Agreement to extend the term and provide for additional compensation as set forth herein.

NOW THEREFORE, for valuable consideration the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1 . The Agreement shall be in effect until September 30,2033, unless sooner terminated pursuant to the provisions thereof.
- 2. CCSD shall pay CUSD \$ 36,000 dollars flat rate annually (excluding any CPI (Consumer Price Index)) increase, in consideration of this Amendment effective October 1, 2023.
- 3. Coast Unified School District will submit a bill to CCSD annually.
- 4. Except as modified herein, all other terms and conditions set forth in the Agreement, as amended, shall remain unchanged and in full force and effect.

WHEREAS, the Cambria Community Services District ("CCSD") has bank accounts at Pacific Premier Bank ("PPB"), as well as an investment account with the State of California Local Agency Investment Fund ("LAIF"); and

WHEREAS, PPB and LAIF require an adopted resolution specifying which banking powers are assigned to CCSD officials and staff; and

WHEREAS, it is necessary to update the assignment of banking powers for the CCSD's bank and investment accounts.

NOW THEREFORE, BE IT RESOLVED, by the Board of Directors of the Cambria Community Services District that banking powers are hereby granted to the individuals listed in the attached Exhibit "A," which is incorporated herein by this reference. This Resolution supersedes all previously adopted Resolutions relating to the assignment of banking powers.
