1. OPENING

A discussion was held and it was decided to send Kermit Johanssen and JoEllen Butler to share some of their ideas with Carlos about what should be done about that problem and possible solutions.

- A. Consideration to Approve the Minutes from the Special Meeting held on September 12, 2017 Mary Webb expressed concern over the fact the minutes said Portable water would be used in the Dog Park. The EIR states that the Park should be a Dry Park. No water period. Commissioner Renshaw expressed that the minutes should have read a discussion was held and no decision was made. She expressed her concern that taking minutes is a hard job and sometimes mistakes are made. She made a motion that the minutes be amended to read a discussion was held about the availability of Portable Water for the dog park. Kermit Johanssen seconded it and the vote was 3 to 1 in favor of amending the minutes. The Park will be dry and no water provided in compliance with the EIR. Commissioner Roche expressed his displeasure with the lack of water for the dog park.
