> Two examples come to mind: Mis-information by a Finance Committee member about components of the most recent Prop 218, the recent accusation by a policy committee member that CCSD is influencing community members' trash bin choices in order for CCSD to benefit financially.

> In the interest of CCSD board transparency and greater community involvement, I cannot understand how standing committee members' incorrect social media posts/comments could be anything but harmful to community members' understanding of current CCSD concerns and projects, besides being in violation of the CCSD policy on Social Media communications.

Written Public Comment:	Thank you President Dean and Board members for taking my comments. As I've become more informed and engaged with various aspects of CCSD governance the past 6 months, including regular Board Meetings and PROS, I have observed several themes that I believe indicate the need for policy and process improvement. First theme is a general lack of trust and transparency of CCSD in the community. My observation is this is not subject to debate, it's simply a fact and needs to be overcome. It's unacceptable and unsustainable to have such a level of angst, animosity and apathy in our community towards our governing body. Second theme, related to #1, is there is significant confusion about policy and process within the Board and its advisory committees, in all manner of business. I observed this with the Mission Country Waste rate subject. Again with more recent processes and discussions related to fire department equipment purchases of roughly \$150,000 for the protective equipment and command vehicle, and in particular the \$500,000 for the Type 5 fire engine. For expenditures of that level, which should be specified clearly in procurement policy, the Board should be presented with at least 2 options, ideally 3; a clear financial analysis of those options with acquisition options (cash, financing, or other); the overall pros and cons of

	each option; and a preferred option recommended and why. This is basic governance and due diligence, and should be clearly spelled out in CCSD Policy. I see this coming as well in the current debate about ZLD with GWI. You simply can't decide on this, even a pilot, without looking at other ZLD providers and other solutions, preferably driven by an RFI and RFP. process. Lastly, in looking at the checklist of Policies included in the agenda packet, many areas lack policy or are in major need of updating, so I applaud and support an exhaustive review I'm no expert on this, but I'm not convinced an internal review is appropriate and will yield the improvements in trust and transparency I know you all want. I believe it would be appropriate to at least consider a LAFCO Municipal Service Review to accomplish your objectives. This is the organization that formed CCSD originally and last conducted an MSR in 2014. I realize there's a lot of history in all this going back decades, but it's time to clean the slate with a third party review and recommendations to update and tighten CCSD Policies to the current realities for CSD governance.
