First of all, I appreciate all that you do for Cambria and its water and infrastructure. Keep up the good work and thank you for all the time you devote to this intensive work.

I am a resident of the **Oak Terrace Mobile Home park located at 1226 Main St., Cambria, CA 93428** that backs up to the Santa Rosa Creek. My home actually backs up to the Santa Rosa Creek.

As you know the March 10, 2023 storm brought a huge amount of rain in a short period of time and a muddy, muddy mess to our Mobile Home park. The streets were flooded and subsequently "mudded." As the creek overran its banks, rain water was unable to drain into the creek and began rising about 1 ft / hour causing an evacuation of the residents.

My home was flooded with water and mud only underneath the mobilehome up to a foot but did not enter the mobile home itself. I am not the absolute "lowest" residence in the park. Others may not have been as lucky. My tool shed and surrounding yard became a mud filled mess.

I'm writing to you today to ask if there is anything that can be done to **shore up the infrastructure along the Santa Rosa Creek where we residents live**, to prevent the next (and unfortunately there will be a next) devastating flooding episode?

As I look out over my back fence, I see some very large trees that came down during the storm, now lying in the creek, directly across from my house. If that group of trees starts to float down the creek and get clogged downstream, the next flood may occur sooner! Can this potential hazard be removed soon? Will there be a clean up the creek project?

This is an over 55+ park and many are on a fixed income here, and unable to leave the area during an evacuation order.

The owners of the park (Waterhouse Management) hired Mercado Landscaping to remove the mud in the streets and from our driveways, which was causing massive walking and driving problems.

Thank you for your attention to this matter and I look forward to your response soon.
