I would like to thank Mr. Dienzo for clarifying a point of confusion regarding the EWS/SWF/WRF Coastal Development Permit application. When he reported that he had submitted responses to all the items on the county's Information Hold, I thought that that would have included Item 1a, the required letters of concurrence from state and federal agencies. He informed me today that there are no such letters, because he is awaiting data from the Instream Flow Study before the agencies are asked to respond.

Therefore, this requirement has not been fulfilled, as he stated. What responses has he filed? He says that the county does not make those documents public until all responses are submitted, but the district can make them available. Please make all documents that the district has submitted available. As they are official communications between public agencies, the public has a right to review them. Thank you.

Mr. Weigold has said that the district will never close the public restrooms, despite the drought. He cites a miniscule percentage of water used by the restrooms. By that logic, none of us need conserve. My personal water use is an insignificant percentage of district use. But conservation is exactly that, small savings by everyone to stretch the water supply so all can be served. Closing the restrooms would also be a step in educating Cambria's visitors in 21<sup>st</sup> century water use. Close the restrooms now.
