CAMBRIA COMMUNITY SERVICES DISTRICT SUMMARY OF ORDINANCE

AN ORDINANCE AMENDING SECTION 3.04.030 OF THE CAMBRIA COMMUNITY SERVICES DISTRICT MUNICIPAL CODE RELATING TO THE WATER RECLAMATION FACILITY

This Ordinance Summary is published in accordance with the provisions of Government Code Section 25124. On May 20, 2021, the Board of Directors of the Cambria Community Services District introduced Ordinance 01-2021 amending Chapter 3.04.030 of the Cambria Community Services District Municipal Code to change references to the Sustainable Water Facility to the Water Reclamation Facility.

Section 3.04.030 contains procedures for relief from fees and charges in special circumstances. Subsection D.3.b of Section 3.04.0303 relating to leaks, contains references to the General Manager having authority to waive SWF usage charges and SWF operating charges for all water used in excess of normal usage. At the March 11, 2021 meeting of the Board of Directors, the Board voted to change the name of the facility from the Sustainable Water Facility (SWF) to the Water Reclamation Facility (WRF). Adoption of Ordinance 01-2021 is one of several items that staff has identified requiring action due to the name change.

The Board of Directors must vote again to adopt the Ordinance. That action is scheduled for Thursday, June 10, 2021, at a regular Board meeting to begin at 2:00 p.m. Pursuant to Governor Newsom's Executive Order N-29-20, members of the Board of Directors and staff will participate in this meeting via a teleconference.
